**Summer 2024 Important Dates and Deadlines**

**Payment Information, Options and Deadlines:**

- I. Once registered you must complete your payment arrangements. All students must log into the Student Finance online system in Saints Connect Portal.
  - If **FULLY covered by financial aid**, simply agree to “Financial Responsibility Policy” terms.
  - If **NOT FULLY covered by financial aid**, enroll in a payment agreement to complete the process.

**ALL STUDENTS NOT FULLY COVERED BY FINANCIAL AID MUST ENROLL IN A PAYMENT AGREEMENT**, even if paying in full, partially covered by financial aid, discounts, grants or employers. A Final Confirmation of Registration email will be issued from the Student Business Office.

- II. Students must withdraw themselves by the deadlines posted if they decide to drop or withdraw from the University. Once Final Confirmation of Registration is received Students will be bound by the terms of the Agreement.
- III. **Reminder to financial aid recipients and students living on campus:** make sure your financial aid, and room and board charges appear on your registration statement/invoice before making payment arrangements. The Total Hours Registered and the Financial Aid Hours should match (i.e. Total Hours Registered 12 = Financial Aid Hours 12). If hours do not match, please contact the Financial Aid Office in the Walter Service Center before contacting the Student Business Office.

- IV. IN PERSON PAYMENT ARRANGEMENTS may be processed in the Student Business Office in the Walter Center during regular business hours.

Arrangements must be made in person from 8:00 a.m. - 1:00 p.m. <b>NOTE: If you do not meet the deadline for Final Confirmation of Registration listed above, your Registration will be cancelled.</b>
