### **Grading policy for spring 2020 semester**

As was announced previously, the Academic Affairs Division and the Faculty Academic Policy Committee have been working on a grading policy and guidelines for dealing with this unprecedented semester. A policy has been developed that seeks to provide our students a range of options for grading. In addition, guidelines are being offered to help you make decisions about the best options for your personal situation. These options apply to the spring 2020 semester only.

Finally, you are reminded to **speak with your adviser and staff from the Financial Aid Office for guidance on your decisions.** Some financial aid and military/veteran benefits may be affected by your decisions. In addition, graduate/professional school acceptance, and professional licensure may be affected by your decisions.

#### **Pass/Fail Option**

- Students will have up to two weeks after final grades are posted to select a pass/fail option by submitting the appropriate form to the Registrar's Office; this extended deadline will allow students to decide on the pass/fail option after seeing their final

grade in a course. The date the final grade is posted is dependent on the session in which a student is enrolled:

- Fast Track B and Weekend Sessions – May 5
- National Online 14-Week Session – May 14
- Traditional Spring Session – May 26

- The grade necessary for a Pass grade is dependent on the particular course and student type.

- If an undergraduate student is taking a course to fulfill General Education requirements, a D- or above is needed to receive a Pass grade. If an undergraduate student is taking a course to fulfill a major or minor requirement, a C- or above is needed to earn a Pass grade.

- Graduate students must earn a grade of B or above to earn a Pass grade.

- A grade of Pass will not be calculated into the Grade Point Average (GPA); a grade of Fail will be calculated into the GPA as an F. If a student repeats and passes the course at a later time, the F would no longer count towards the cumulative GPA.

### **Incomplete Option**

- The rules for granting an incomplete in a course are being relaxed. Previously, students were required to complete at least 75% of coursework before an incomplete could be granted. Under the policy for this semester, faculty will have greater flexibility in granting an incomplete.

- **Note for Graduating Students:** An incomplete will delay the conferred date of your degree.

### **Withdrawal Option**

Some withdrawal deadlines are being extended due to the switch from face-to-face to online instruction. The new deadline for students enrolled in Weekend I and Weekend II is April 17. For students in the San Antonio Traditional Semester the deadline is April 30.

## **Summer semesters online**

To help you make plans for summer, the decision has been made that all summer instruction will take place online. This includes Summer I, II and III, Fast Track A and B, Weekend I and II, and National Online 14-Week Session.

While we hope our campuses will be open this summer, moving summer instruction online allows you to make your summer plans now.

## Health insurance options

If you have lost your current healthcare coverage, you may have options. An event, such as loss of a job because of current economic conditions, may be considered a “qualifying event” and would allow you to enroll in a different insurance plan. Below are a few options for consideration.

### Student Insurance through Wellfleet

The eligible student who satisfies credit requirements, could possibly enroll in the OLLU sponsored student health plan through Wellfleet. Generally, Wellfleet requires a letter from the other insurance company or employer documenting the loss of coverage and the date. The enrollment period is 60 days from loss of coverage. The student would need to complete a Wellfleet enrollment form and then pay the premium directly to Wellfleet. The premium is prorated from the date of the loss of coverage to the end of the policy year (7/31/20). However, Wellfleet cannot enroll the student until all information and payment is received.
