



CampusClear app instructions and information

All OLLU students and employees will be required to conduct a self-screening using the #CampusClear app before coming onto campus. The app is available through the AppStore on iPhones and Google Play for Androids.



How to set up the app:

1. Download the free app via the AppStore or Google Play.
2. **Allow #CampusClear to send you notifications.** If you forget to allow for notifications, simply delete the app and reinstall it. When it says it would like to send you notifications, select ALLOW.
3. Enter your ollusa.edu email address when it asks you for an email. It won't accept email addresses that don't contain the "ollusa.edu" extension (i.e., it will not accept gmail, yahoo, hotmail etc).
4. You will receive a confirmation email from IvyTeam (team@ivy.ai) with a link to complete authentication. Click the link and then you are ready to use the app
5. Set up takes 3-5 minutes.

Follow these steps to self-screen:

1. Open the app before coming onto campus.
2. Answer the one question #CampusClear asks.
3. Follow the guidance provided by the app. The app will tell you whether you are clear to come onto campus or not.
4. Students and employees must self-screen via the app **every day they plan to come to campus.** You do not have to self-screen via the app on days you are not coming to campus.

What does the #CampusClear app do?

1. Enables students and employees to self-report symptoms or COVID-19 infection daily in an easy and convenient way.
2. Clears individuals to access university facilities.

3. Gives OLLU actionable information to manage emergent risks.
4. The app is not a source of medical advice. Check with your doctor if you have any health concerns.

What information does #CampusClear collect about me?

The app will collect the following information:

Your email address

Your email address will be stored encrypted, rendering you totally anonymous. Your email may only be decrypted by an authorized administrator of the university for the purposes of campus management.

Your Daily Survey Answer

We will store your daily survey answer for campus management purposes.

What Data We Don't Collect

#CampusClear will NOT collect your name or any other personally identifiable information. It will NOT collect locations. The app does not use GPS or Bluetooth.

What do #CampusClear and OLLU do with this information?

#CampusClear will only share your information with OLLU. It will never disclose any information to any third party.

OLLU may access, use, and disclose survey information as it determines necessary, in the university's discretion, in order to protect the health and safety of the OLLU community during the COVID-19 pandemic.

Permitted uses of survey information include, but are not limited to, disclosure of your identity and reported symptoms to OLLU Health Services, human resources officers, supervisors, facilities personnel, and others at OLLU who have a need to know this information.

OLLU will never sell or disclose any information to any third party.
